The Boca Raton City Council is accepting applications from persons interested in appointment to City Council Seat B, which is expected to become vacant on November 30, 2008, due to a resignation.

To qualify for appointment, applicants must be at least 18 years old, a resident of the City of Boca Raton, and a registered elector of the City.

The appointment to fill the vacancy would be for a term that would begin on the effective date of the appointment and end March 31, 2009. The remaining two years of the term assigned to City Council Seat B (March 31, 2009 to March 31, 2011) will be filled during the City's regular election to be conducted March 10, 2009.

City Council is expected to consider the appointment at their Regular Meeting on December 9, 2008. That meeting will begin at 6:00 p.m., or as soon thereafter as possible, in the Council Chamber, 201 W. Palmetto Park Road. Interested persons should submit an application to the City Clerk's Office on or before Wednesday, December 3, 2008 at 5:00 p.m.
