RULES AND REGULATIONS:

1. Amplifying sound devices are prohibited.
2. Conduct yourself in orderly manner. Be polite and courteous.
3. If requested to leave the property, do so immediately and do not return to the same location.
4. Permit should be kept at location of event.
5. Wear identifying uniform or carry a form of identification. Each participant must know the permit number.
6. Do not stand or walk upon paved streets or upon medians, paved or unpaved.
7. Do not block or impede pedestrian traffic on sidewalks or bike paths.

ONLY ONE (1) SIGN IS ALLOWED ON PREMISES DURING EVENT.

By acceptance of this permit, the sponsor agrees to indemnify and hold harmless the City of Boca Raton, its officers, employees and agents from and against all loss, costs, expenses, including attorneys' fees, claims, suits and judgments, whatsoever in connection with injury to or death of any person or persons or loss of or damage to property resulting from any and all operations performed by sponsor, its officers, employees, and agents under any of the terms of this special event permit.

If any unforeseen circumstances occur and/or the sponsor fails to meet the requirements the City has set forth, the City of Boca Raton shall have the right to cancel or stop the event either before commencement of the activities and/or during the event.
